



## PNC Declares Dividend Of 95 Cents On Common Stock

PITTSBURGH, Oct. 4, 2018 /PRNewswire/ -- The board of directors of The PNC Financial Services Group, Inc. (NYSE: PNC) declared a quarterly cash dividend on the common stock of 95 cents per share. The dividend will be payable Nov. 5, 2018 to shareholders of record at the close of business Oct. 17, 2018.

The board also declared a cash dividend on the following series of preferred stocks:

- **Series B:** a quarterly dividend of 45 cents per share will be payable Dec. 10, 2018 to shareholders of record at the close of business Nov. 16, 2018.
- **Series P:** a quarterly dividend of \$1,531.25 per share (\$.3828125 per each depository share, 4,000 of which represent one share of Series P preferred stock) will be payable Nov. 1, 2018 to shareholders of record at the close of business Oct. 17, 2018.
- **Series Q:** a quarterly dividend of \$1,343.75 per share (\$.3359375 per each depository share, 4,000 of which represent one share of Series Q preferred stock) with a payment date of Dec. 1, 2018 will be payable the next business day to shareholders of record at the close of business Nov. 14, 2018.
- **Series R:** a semi-annual dividend of \$2,425.00 per share (\$24.25 per each depository share, 100 of which represent one share of Series R preferred stock) with a payment date of Dec. 1, 2018 will be payable the next business day to shareholders of record at the close of business Nov. 14, 2018.
- **Series S:** a semi-annual dividend of \$2,500.00 per share (\$25.00 per each depository share, 100 of which represent one share of Series S preferred stock) will be payable Nov. 1, 2018 to shareholders of record at the close of business Oct. 17, 2018.
